

# HOW TO SUPPORT THE NATIONAL OPERA STUDIO

## **SINGLE GIFTS**

Donations of any amount can be given by Cheque, Charities Aid Foundation (CAF) Vouchers or credit card (Mastercard/Visa). Please complete Section 1.

## **REGULAR GIFTS**

Banker's Orders enable you to support the National Opera Studio with regular gifts and can be paid Monthly, Quarterly or Annually. Simply complete the Banker's Order in Section 2.A Banker's Order will continue until the end of the period stipulated or until the donor instructs their bank to stop the payments, which can be done at any time.

## **GIFT AID DECLARATION**

If you pay UK tax, we can reclaim it and you can increase the benefit of your donation.

The National Opera Studio is able to reclaim 28 pence for every £1 you give.

If you are paying UK Income or Capital Gains tax the National Opera Studio is able to reclaim the tax you have paid on every gift as long as you have paid the equivalent amount of tax to the amount being reclaimed. All you need to do is fill in Section 3 - Gift Aid Declaration.

## **HIGH RATE TAXPAYERS**

High rate taxpayers can claim further tax relief in your self-assessment tax return.

## **GIFTS OF SHARES**

Gifts of quoted securities are now eligible for tax relief. The donor gives their shares to the National Opera Studio and their taxable income for that year is reduced by the value of the shares on the date they are given.
